**SUMMARY**

This report provides Council with an assessment of Planning Application WH/2025/2 at 490-500 Burwood Highway, Vermont South, which seeks the approval for the use and development of the land for a Retirement Village, removal of vegetation and alteration of access to a road in a Transport 2 Zone.

The key considerations for the report include whether the proposed development achieves an acceptable built form outcome in relation to the 'Residential Growth' zoning, in balance with policy and character objectives for both the surrounding area and the applicable decision guidelines of the Design and Development Overlay Schedule 6 and Heritage Overlay Schedule 23. Consideration must also be afforded to car parking and road safety requirements and whether the proposed development of the subject site would avoid unacceptable offsite amenity impacts for nearby residences.

As part of the planning permit application process, notice was given to adjoining properties and through placement of signs along the Burwood Highway frontage. A total of 51 objections were received. The objections raised issues relating to building bulk and excessive scale of form, overshadowing, overlooking and concerns around increased traffic impacts. A consultation forum was held on 13 November 2025, chaired by Councillor Gunn, where the issues were explored, however, no specific resolution was reached between the parties. Objector concerns have been addressed in further detail throughout this report.

The application was referred externally to Transport for Victoria for changes of vehicle access into Burwood Highway and the Department of Energy, Environment and Climate Action with regards to vegetation removal. Both referral authorities have supported the application subject to conditions.

This report assess the application against the relevant provisions of the Whitehorse Planning Scheme, including the purpose and decision guidelines of the Residential Growth Zone, Development Contributions Plan Overlay Schedule 1, Design and Development Overlay Schedule 6, Environmental

Audit Overlay, Heritage Overlay Schedule 23, Significant Landscape Overlay Schedule 10, Vegetation Protection Overlay Schedule 5, Clause 52.06 (Car Parking), Clause 52.17 (Native Vegetation), Clause 52.29 (Land adjacent to the Principal Road Network) and Clause 65 (Decision Guidelines) and concludes that the proposal is acceptable subject to conditions.

### SUMMARY

The purpose of this report is to seek Council approval for the budget allocation and contract award for the demolition of the vacated Gowanlea Senior Accommodation building located at 1049 Whitehorse Road, Box Hill.

The building is no longer required for Council purposes and presents safety and security risks, including unauthorised access, vandalism and anti-social behaviour. Demolition will return the site to a safe and manageable condition, allowing Council to consider future options for long-term use.

A selective tender process was conducted via the State Government's Construction Supplier Register (CSR). Five submissions were received and evaluated against the approved weighted criteria. City Circle Demolition & Excavation Pty Ltd (City Circle) achieved the highest score and is the preferred tenderer.

The recommendation is to accept City Circle's tender for a lump sum amount of \$834,404 (excluding GST) and allocate a total project budget of \$1,165,000 (excluding GST).
