

Whitehorse community survey regarding North East Link

The State Government has committed to constructing the North East Link (NEL), a freeway standard road connecting the M80 Ring Road in Greensborough to the Eastern Freeway at Bulleen Road. The project also includes the widening of the Eastern Freeway between Bulleen Road and Springvale Road. Council resolved at its meeting on 11 December 2017 to oppose the State Government's decision to select this alignment. At its meeting on 19 March 2018, Council further resolved to host a public forum to hear community views regarding NEL. In conjunction with the forum, a survey was distributed to invite community comments regarding NEL. This report lists the results of the community survey.
