When you start making separate key points (1.4) that places a greater focus and emphasis on one particular group of people, it immediately begins to segregate, exclude and cause division. Of course the First Nations Peoples and their history are important but if you truly want to be inclusive you must acknowledge everyone equally, not just based on history but with all who live in Whitehorse now! In your opening letter, you acknowledge the traditional owners of the land and state that 'this' has been your constant consideration throughout the process of creating the vision. I'm not exactly sure what 'this' means but from the outset, it appears that this whole report is going to be constrained by not offending the Indigenous people. If this is the case then I think they would already be offended at what is being built on their land in Whitehorse! So there is the conundrum....creating a report that 'says' all the right things and putting those words into action. That will be your challenge and the proof of whether this report is really going to serve any purpose.
